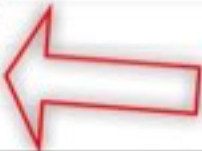

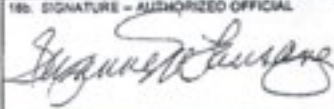

If a ConverDyn Customer requests shipment of foreign-obligated natural uranium during the term of this export license, the license will be amended to include it.
